Terms & Conditions for Change of Ownership 更改註冊客戶協議書條款與細則

With the completion (signed by both parties) of the Change of Ownership Form (the "Form"), The Transferor and the Transferee
have reached a mutual agreement to the transfer of the ownership of the service(s) and service/circuit number(s) specified on the
Form.

轉租人及承租人填妥「更改註冊客戶表格」(需由雙方簽署)後,雙方就轉租事項達成協議。

2. The Transferee must fill in the Form. The signed Form must be accompanied by the copy of the Transferee's valid HK identity card or a copy of his/her passport for verification of his/her identity. If the Transferee cannot obtain an agreement from the Transferor, the Transferee must fill in, the section "Statement of Indemnity for Business or Residential Service(s)". The signed Form must be accompanied by substantial proof that the Transferee is either a kin to the Transferor or is in possession (both lawfully and actually) of the premises where the Service / Circuit Number (s) as specified on the form is installed.

- 6. Once the Transferee agrees to accept all of the terms and conditions for change of ownership, HGC will proceed the transfer of all service(s) and service/circuit number(s) from the Transferor to the Transferee after the Form is accepted and all information received is verified.
